



## BOARDING AGREEMENT

**Please read, initial each and sign below to acknowledge your understanding and agreement.**

1. \_\_\_\_\_ I agree that my pet(s) are being cared for by Heavenly Care Kennels without liability on Kennel's part for loss, illness, damage from disease, death, escape, theft, fire, injury or harm to person, other pets or property by said pet. I fully accept all risks of illness or injury that may be incurred while being boarded such risks include, but are not limited to cuts, scrapes, and possible contagious illnesses such as upper respiratory infections (of which only one, "bordatella", currently has a vaccination available.)

2. \_\_\_\_\_ I agree to be solely responsible for any and all acts or behavior or harm caused my pet(s) while in the care Heavenly Care Kennels. I agree to take precautions against contagious illness and parasite exposure by consulting with my Veterinarian prior to my dog attending at Heavenly Care Kennels.

3. \_\_\_\_\_ I recognize and accept that boarding may be stressful to the pet(s) and will not hold Heavenly Care Kennels responsible for any stress induced illness, injury, behavior change, or weight gain or loss. Furthermore the pet(s) may possible contract an illness, and will not hold Kennel responsible for expenses or charges incurred by Owner for veterinarian services or medicine after the pet's stay.

4. \_\_\_\_\_ I understand that in the event of injury, Heavenly Care Staff may or may not notify me immediately. If the injury is not serious, staff may allow my dog to continue to play, and then notify me when I come to pick up my dog. If the injury is serious, I will be notified immediately. If unable to reach me in an emergency situation, Heavenly Care reserves the right and sole discretion to administer aid, and or to seek available veterinarians without liability, and I agree to promptly pay for all medical treatments received. Furthermore I agree to review and sign the Health Care Agreement with Heavenly Care Kennels.

5. \_\_\_\_\_ I understand that my pet(s) will be hand walked using a collar/harness and lead on premises. **UNLESS OTHERWISE OUTLINED BY OWNER**, Owner gives permission for the pet(s) to play with Kennel toys, use Kennel bedding and eat Kennel cookies or food.

I understand during **designated holiday periods, all days reserved for the pet will be paid for by the owner**. If Owner picks up the pet prior to the scheduled departure date, Owner will pay for all days remaining in the scheduled reservation. I agree to pay all cost of any property damage or personal injury caused by my pet during its stay. I understand that any animal left for ten days beyond the agreed date of pick-up will be considered abandonment and may be disposed of at the discretion of the kennel owner.
